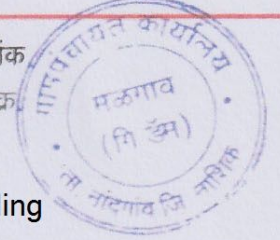



19. We agree that the examination of our students may not necessarily be conducted at our study center.


20. We agree to send our counsellors and experts for paper setting question bank development and other activities carried by YCMOU.




